Rule 2.01 (n)

9. Managements conducting graded common mark events shall provide a minimum of one prize or trophy for each grade.

Can NSWCTA ask ACTA to develop further guidelines to this rule to have uniformity across the states with a view to have ACTA include guidelines in the rule book - uniform guidelines need to be established as to who is entitled to what prizes.

Example

At a Nationals, a Lady, junior or Veteran can win overall and also win their section. At club level it varies from club to club. Do we want to develop guidelines for club level shoots?

Noted as read, No further action required at this time.

Clubs should display how they pay out prizes in their conditions of entry.

General Business:

Don Power: NSW has been allocated the 2016 Commonwealth Carnival. This needs to be accepted from the ACTA and allocated a date and location.
