The NSWCTA sought a solicitor's opinion of the breech of the ACTA and they found the ACTA to have no legal grounds on their reason behind disaffiliating a club from membership.

Clubs in NSW could be targeted under the same grounds, therefore the NSWCTA sought legal advice to gain a better understanding of the legal rights our clubs would have if placed in the same situation.

State Handicapper John Maxwell will report on the Handicappers Forum that was held on 2 February 2018: Fred Rapley, Don Turner, David O'Brien, Brett McAllister, Joe Marshall & John Maxwell attended a forum outlining the new ACTA Rules book that was released 1.1.2018.

Due to some issues at club level with handicapping, the association thought that our first step for education was at zone level to then filtrate back to the clubs. A representative from each zone was present.

A handicapper's package will be distributed to all clubs by the ACTA in April 2018.

#### Coaching Directors Report

David reported that access to ACTA records is limited to him.
