- At the present time the ACTA, allows SSAA and Field and Game Federation and Field and Game Australia members to shoot 5 Stand Sporting only on ACTA grounds. Remove the word "5 Stand."
- Change wording at the front of each section in Rule Book from 'Guidelines for Referees' to 'Requirements for Referees
- Immediately advise all member associations and clubs of the rule change of the following to read: The
 use and carriage of military style shotguns are prohibited on ACTA grounds at all times. New Rule 4.08
 (d), 8.08 (d) and 11.02 (h).

RECOMMENDATION: Rules and guidance for AA elite need to be listed in the ACTA Rule Book.
