#### 5) ACTA DELEGATES REPORT

Colin Kneebone & Kim Nealon reported:

The last ACTA meeting was referenced to the acceptance in Rules changes.

- One rule change to note; No free target at the start of the day.
- Couldn't get through the increase of targets shot from 200 to 400 before grade change.
- New President, Mal Dyson was appointed.
- Nugent remains to be involved with the new constitution along with Alan Styles, Mal Dyson, Colin Kneebone, Robert Nugent, plus two external members on the committee.
- The Range Function Centre is proving to be a costly asset.
- National Grounds have a curfew of 8pm as a courtesy to locals only, it is not a council enforced curfew.
- Meeting was held with the council and the community due to the Rail Trail.

#### 7) SPECIFIC BUSINESS

a) Request from the Southern Zone – Media production designed to educate new shooters – The Zone has put forward the idea to NSWCTA to request the idea of having some short videos produced for

shooter education. The Following motion was put forward:

(MOTION: Request the NSWCTA to put forward to the ACTA a recommendation for a person with the appropriate skills, e'g. Russell Mark, to produce a video regarding refereeing, scoring, etiquette and responsibilities.)

<u>Recommendation:</u> Request that the ACTA make available short videos on their website to cover the raised issues above. This would especially benefit new shooters.

### ACTION: Dan Power to draft up the official proposal to submit to the ACTA.

This would be operational videos, How to fill in a score sheets, How to fill in a nomination form, how to move about the lanes, how to referee, what is expected of a shooter etc.

b) Request from the Southern Zone – the following motion was put forward:

(MOTION: Request the ACTA to clarify point 2 and 4 for Officials – "ACTA RULE BOOK –

MANDATORY REQUIREMENTS FOR OFFICIALS, TRAP – POINT 4" The Referee should ask his scorer to stand close enough to him so that the Referee can see the score sheet, and the scorer can observe the target as a check Referee. The rule contradicts itself. Point 2 "The Referee must stand where he has a clear view of targets and competitors, preferably between lanes 2 and 3, approximately 2 metres behind the competitors shooting mark. If there is excessive background noise the Referee may move between lanes 2 and 4 in order to hear the competitors call so as to give all competitors equity of competition.")

It is thought that this is being addressed in the new rule book to be released 2020.

ACTION: Carry over to a meeting after the new rule book has been released.

c) <u>Dan Power – Hall of Fame long</u> breaks, masters awards and grand slam legs. We need clarity in regarding the rules regarding scores shot in other countries (eg USA) where the rules are not the same as ACTA and using them to claim ACTA awards. The consistency in this area damages the credibility of the Hall of Fame Awards. We desperately need to get the ACTA to settle this once and for all, with no grey area.

This issue has been corrected it just hasn't been released to the public as yet. This will be covered in the new edition of the Rule Book.

d) <u>Mark Rogers - NSW State Skeet Carnival</u> – Possibility of Cecil Park Clay Target Club hosting this State Carnival. Sam Agostino is the President of the club and a keen Skeet Shooter, he is more than willing to work out what it will take to get the Carnival hosted there.

It is quite expensive to hire Sydney International Shooting Centre, it may not even be beneficial to move the carnival due to rising costs.

e) <u>Mark Rogers – Risk Assessments</u> – NSWCTA ensuring that all NSW Clubs have Risk Assessments in place – This may need to be audited.

RECOMENDATION: Resend to clubs the Risk Assessment. Delegates to push clubs to create or adapt the supplied risk assessment.
